1. OLD BUSINESS

- A. Secretary's Report Ken English

- D. Water Monitoring program Update Fred Luckeroth/Roger Stecker
 - 2010 Secchi readings thus far
 - Stecker measurements: South End measurements
 - 5/23/10 30'
 - 6/20/10 30'
 - **7/9/10 25**
 - Fred Luckeroth reviewed the findings of the PCA water quality report.
 But these are from previous years.
 - Boot Lake water quality continues to be excellent.
- E. Update on Minnesota's Shoreland Rules and Standards Dan The proposed standards include, but are not limited to:

better water quality standards achieved by improved rainwater runoff management; increased drainfield setbacks, and higher shoreline buffer standards for new development; greater protections for vulnerable areas (e.g. sensitive lakeshore, trout streams, bluffs); and improved standards for planned unit developments.

Other updated standards include specific resort standards allowing for expansion and improvements while addressing water quality and habitat concerns; higher standards for new development and new lots (e.g. impervious surface, open space, shoreline buffers); advanced subdivision controls, including promotion of conservation subdivisions and other creative developments over conventional (lot and block) subdivisions; and revisions that allow for more options for local government implementation.

The preliminary draft also shows how general elements of the wild and scenic rules may be incorporated into the shoreland standards.
