High Speed Internet Report Kenneth Shepard

As you probably know, Hughes Net satellite service received federal grant money to provide high speed Internet service to under-served areas, and a half dozen or so residents signed up for the offer. Others who wanted to sign up were told they lived in adequately served areas already and did not qualify, even if their next door neighbors did qualify. Despite some dark spots, most people with the service are happy with it. My download speed this morning was 2416 kbps, which is up from around 10 kbps when we used dialup. This is faster than Hughes promised us. However, they limit a user's daily download amount, and it is easy to exceed this when updates are needed.

When you exceed your limit, bad things happen. Your speed drops to as low as 5 to 10 kbps, and it stays there until midnight. If you are lucky, your speed returns to normal, but sometimes they punish you and wait an additional 24 hours to reset your speed for the next day. If you are desperate, you can buy additional time for \$5 or use a free token which is sometimes available. If you watch a lot of granny porn, you can upgrade to the next level or watch the seniors strut their stuff between 2 a.m. and 7 a.m., when downloads are not monitored.

One additional dark spot is that your equipment carries a one year warranty, but when it fails, it is replaced by equipment with only a 90 day warranty. Go figure.

The Hughes program is still available as of today. Check your eligibility at 1-877-516-7618. The savings are significant over their regular service, although they always have "special deals" available.

Local companies are still considering copper or fiber based systems, but they are not sharing much information at the present.
