## Boot Lake Association Annual Meeting – August 11, 2019

## I) OLD BUSINESS

- a. Secretary's Report: Secretary's report was accepted as recorded. Approved by Darlene Swanson Second George Thelen
- b. Treasurer's Report Craig Niemen presented current bank balance, major expenditures, current membership. Report approved by Judy Theisen, Second Kathleen Lafreniere
- c. Loon Count Update: Presented by Chris Luckeroth. There was one successful nesting site on one of the three loon platforms set out by the association. A second pair of loons nested on a natural nest along the shoreline near the boat access. A total of three chicks were born, two surviving to date. Total adult count not available
- d. Water Monitoring program Update
  - d.i. Fred Luckeroth continues to measure and report secchi disk readings to the appropriate state agency. Early summer readings were poor 9,10 and 12 feet. Residents have noted the green color of the water, which was noted to be common event this spring in the regional lakes. This was not an isolated Boot Lake event. August reading was back to prior years readings 17ft. Best readings have been in the mid-twenty ranges.
  - d.ii. Fred Luckeroth was told this springs water clarity unlikely caused by lakeshore development. Lake front development can contribute to water quality.
  - d.iii. Fred Luckeroth also shared that the association purchased a book resource that is available to the association members that covers good lakeshore development and plantings that enhance wildlife and lake water quality.
  - d.iv. AIS issues. Becker County has placed an inspector at the public landing for this summer. The inspector will be in place until the end of August. The inspector has not found any violations in his work this summer.
  - d.v. It has been recommended that Boot Lake residents watch the introduction of any used equipment that will go into the water until is has been dry docked at least 21 days. This length of dry dock will insure there is no AIS infestation present on the used equipment that would infect Boot Lake.
  - d.vi. Becker County is reporting AIS being found in Cormorant Lakes and Nelson Lake. 19 lakes with zebra muscle infestation and 30 total lakes with infestations. Hubbard County had no new infestations for 2019, Benedict and Garfield Lakes have AIS.
  - d.vii. Boot Lake Association has provided pamphlets to the two resorts for them to distribute to their quests.
  - d.viii. One question was raised about the classification of wild rice as an AIS issue. No one present could address this question with any authority. Wild rice is native to Minnesota but could it overtake portions of the lake and diminish the appearance and quality of lake water.

- e. Website: Website has been updated and can be found at minnesotawaters.org. Also you can google Boot Lake and it will take you to the Website. The website contains historical data and meeting minutes for anyone interested in those items.
- f. Coffee Club: Chris Luckeroth passed around the list of dates for sign ups. The final list will be available from Chris. It is available on the website.
- g. Email contact list was updated for those members present.
- h. July 4<sup>th</sup> Boat Parade: Kathi Doroff reported on this years parade and contest. There were no issues reported in having the resorts be the judges for the best decorated boat in the parade.

Black bears are usually aware of our presence long before they would be spotted and by nature would avoid any interaction.
